It will also provide knowledge of substantive as well as procedural contents of Industrial Relations Laws, Understanding of Social Security Legislation, Contract Labour Law and Wage Laws.

There is no programme fee. The Institute would bear the expenditure on boarding and lodging of the participants during the training period. The Institute would also reimburse to and fro 3-tier AC train fare. It may be ensured that nominee(s) should have Aadhar number. The nominations of only those participants will be accepted who have Aadhar number and bank account. The reimbursement of travel fare to the nominees would be made through NEFT only. The nominee(s) may be informed to bring their Aadhar Card and bank details (name of bank, name of bank branch, IFSC code and bank account no.) with them. The bank details may be indicated by nominee while filling up TA form at the institute. The participants from Assam and Meghalaya can submit a copy of Voter ID/ Driving Licence in place of Aadhar card, while filling up TA form at the institute. All the nominees may be informed accordingly.

We request you to kindly nominate 05 personnel from your organisation (preferably those who have not attended any training programme in our Institute earlier). We will highly appreciate participation of women. STAY ARRANGEMENT

Stay arrangements will be made in the hostel of V. V. Giri National Labour Institute. The boarding and lodging will be provided from the afternoon of March 01, 2020 till the forenoon of March 07, 2020. Accommodation would be on twin-sharing basis. The additional cost of early arrival or extended stay will be borne by the individual participants.

PROGRAMME FEE

No fee will be charged. The Institute would bear the expenditure on lodging and boarding of the participants during training period only.

TRAVEL EXPENSES

1. No fee is charged from the participants.
2. The Institute would reimburse travel expenses of the participants for 3 tiers AC Train fare from their place of work to NOIDA on production of ORIGINAL ticket for inward journey and for return journey, a photo copy of 3-tier AC CONFIRMED ticket shall be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconvenience.
3. It may be ensured that nominee(s) should have Aadhar Card and bank account. The nominations of only those participants will be accepted who have Aadhar number and bank account. The reimbursement of travel fare to the nominees would be made through NEFT only. The nominee(s) may be informed to bring their Aadhar Card and bank details (name of bank, name of bank branch, IFSC code and bank account no.) with them. The bank details may be indicated by nominee while filling up TA form at the institute. All the nominees may be informed accordingly.
4. **The participants from Assam and Meghalaya can submit a copy of Voter ID/ Driving Licence in place of Aadhar card**
5. The local conveyance to be reimbursed would be restricted to the actual expenditure incurred or Rs. 750/- whichever is less

ELIGIBILITY

1. Participants should be above **22 years and below 50 years of age;**
2. Should be personally engaged at grass roots level activities for at least past two years;
3. Should have working knowledge of Hindi/ English

NOTE:

1. Please note that those who have already attended institute's earlier programme are not to be nominated. If so, they shall be immediately sent back and no travel allowance will be reimbursed.
2. Spouse and family members are not allowed to stay in the Institute's hostel.

3. Only members of trade unions and NGOs should be nominated. Please ensure that spouse or relatives of nominee, who are not member of trade union/NGOs, should not be nominated.
4. Participants are requested to book their return journey ticket in advance from their own place.
