AIM

The programme aims at strengthening competence for discharging quasi-judicial role.

OBJECTIVES

- To develop conceptual framework for discharging quasi-judicial functions in the context of present socio Economic scenario.
- To discuss problems of quasi-judicial authorities
- To appreciate emerging trends in labour laws and judicial interpretations.
- To have the understanding of relevant areas of Constitutional Law and Administrative Law.

COURSE PROFILE

Role and duties of quasi-judicial officers under various Labour enactments , problems in discharging quasi-judicial role and ways and means to solve them, principles of natural justice and recent labour jurisprudence.

METHODOLOGY

Lectures, group discussions, experience sharing.

PARTICIPATION LEVEL

Quasi- Judicial Officers from State Government, Union Territories and Office of Chief Labour Commissioner (C)

ELIGIBILITY

1. Participants should be above **21 years and below 60 years of age;**
2. Should have working knowledge of either Hindi or English.

NOTE:

1. Please note that those who have already attended institute's earlier programme may not apply again. If so, they shall be immediately sent back and no travel allowance will be reimbursed.
2. Children, spouse and family members are not allowed to stay in the Institute's hostel.
3. Participants are requested to book their return journey ticket in advance from their own place.

FEES & TRAVELLING REIMBURSEMENT

There is no programme fee.

1. The institute will reimburse travel expenses by bank transfer; for participants who have an Aadhaar number and a bank account. It's important for nominees to bring their bank details (bank name, branch, IFSC code, and account number) to fill up the TA form. **Participants must attach the original ticket for the inward and outward journey. Without proper tickets, no claims will be re-imbursed.**
2. The institute will reimburse 2nd class sleeper (Non-AC) train or bus fare (Non-AC) from their place to VVG NLI (NOIDA) and back. Local conveyance at the maximum of ₹350 for (Delhi & NCR) and ₹500 (for other states except North East States).
3. For participants from the North Eastern States, the Institute will reimburse 3-tier AC train fare and local conveyance, subject to a maximum limit of ₹750. **In case a participant does not possess a 3-tier (AC) return ticket, reimbursement will be made for II sleeper class fare only, however the difference of 3-tier (AC) train fare shall be paid only upon submission 3-tier (AC) return ticket.**
4. Officials entitled for higher class may claim their Travelling Allowance from their own organisation.
5. For extended stay or early arrival, lodging & boarding charges would be borne by the participants.
