The programme has been designed for Government officials and trade union leaders with the aim to familiarize them with the social protection programmes and to develop techniques and strategies for initiating micro-level livelihood programmes. There is no programme fee. The Institute would bear the expenditure on boarding and lodging facility and will reimburse to and fro Second Class Sleeper train fare on production of tickets to the participants. It may be ensured that nominee(s) should have Aadhar number. The nominations of only those participants will be accepted who have Aadhar number and bank account. The reimbursement of travel fare to the nominees would be made through NEFT only. The nominee(s) may be informed to bring their Aadhar Card and bank details (name of bank, name of bank branch, IFSC code and bank account no.) with them. The bank details may be indicated by nominee while filling up TA form at the institute. All the nominees may be informed accordingly.

We request you to nominate 04 officials from your organisation/department. We will highly appreciate participation of women. It may be ensured that those who have already attended institute's earlier programme are not nominated again. Taking into consideration the limited number of seats, the Institute will be constrained to admit only 04 participants from one organisation/department on first-come-first-serve basis and regret acceptance thereafter. OBJECTIVES

- Familiarize participants with the social protection programmes and micro level experiments in the country
- Understand the role of different institutional mechanisms to deliver social protection and sustainable livelihood
- Discuss the role of government, trade unions and community leaders for initiating rural livelihood protection programmes

COURSE PROFILE

Social Protection of Informal Sector Workers; Programmes and Schemes on Social Protection; Sharing Micro level Experience of Social Protection Practices; Capacity building for initiating community level programmes

METHODOLOGY

Lectures, individual and group presentations, sharing case studies.

PARTICIPATION LEVEL

Government Officials and Representatives of Central Trade Unions. Both English and Hindi working knowledge is required.

ELIGIBILITY

1. Participants should be above **22 years and below 50 years of age**;
2. Should be personally engaged at grass root level activities for at least past two years or implementing government livelihood programmes;
3. Should be fluent in either Hindi or English.

NOTE:

1. Please note that those who have already attended this programme are not to be nominated. If so, they shall be immediately sent back and no travel allowance will be reimbursed.
2. Spouse and family members are not allowed to stay in the Institute's hostel.
3. In case of trade union representatives, please ensure that spouse or relatives of nominee, who are not member of trade union, should not be nominated.
4. Participants are requested to book their return ticket in advance from their own place.
5. Under no-circumstance other than IInd class ordinary fare will be entertained.

PROGRAMME DATE

February 17-21, 2020

The training programme will commence at 10.00 a.m. on February 17, 2020 and will conclude on February 21, 2020 afternoon.

VENUE

V.V.Giri National Labour Institute

The Institute is situated near Prakash Hospital and NTPC Office. The distance of the Institute from New Delhi Railway Station is 20 Kms. Noida City Centre Metro Station is about 1.5 kms from VVGNNLI, Noida.

STAY AND FOOD ARRANGEMENT

Stay arrangement will be made in the hostel of V.V. Giri National Labour Institute on twin sharing basis. The boarding and lodging will be provided by the Institute from the afternoon of February 16, 2020 till the forenoon of February 22, 2020. For extended stay or early arrival, lodging & boarding charges would be borne by the participants.

TRAVELLING EXPENSES

1. No fee is charged from the participants.
2. The Institute would reimburse travel expenses of the participants for 2nd class sleeper Train/Bus fare from their place of work to NOIDA on production of **ORIGINAL** ticket for inward journey and for return journey, a photo copy of **CONFIRMED** ticket should be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconveniences.
3. It may be ensured that nominee(s) should have Aadhar Card. The nominations of only those participants will be accepted who have Aadhar number. The reimbursement of travel fare to the nominees would be made through NEFT only. The nominees should be instructed to provide Aadhar Number, Bank Account Number, IFSC Code of Bank, Bank Name and Branch of the Bank. The bank details may be indicated by nominee while filling up TA form at the institute.
4. The local conveyance will be reimbursed restricted to the actual expenditure incurred or Rs. 500/- whichever is less (Rs. 350/- for Delhi & NCR).
5. The Institute would reimburse travel expenses of the North Eastern participants for 3 tier AC Train fare from their place of work to NOIDA on production of **ORIGINAL** ticket for inward journey and for return journey, a photo copy of 3rd AC **CONFIRMED** ticket shall be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconvenience. The local conveyance to be reimbursed would be restricted to the actual expenditure incurred or Rs. 750/- whichever is less.
