We are glad to inform you that the Institute would be organising a **Capacity Building Programme for Understanding Labour Codes** during **February 06 - 07, 2025**.


The Government of India initiated a comprehensive process of labour law reforms by undertaking the exercise of codification of large number of existing labour legislations in four major labour codes. Hence, an understanding and discussion of the key features of these codes becomes quite relevant and important for all the stakeholders, all the more in the newly emerging labour and employment scenario in the country. It is in this context, VVGNI has taken a decision to conduct training programme on Labour Codes for promoting and understanding of the key features and implications of these codes for various stake-holders.
