सहर्ष सूचित किया जाता है कि वी. वी. गिरि राष्ट्रीय श्रम संस्थान, नौएडा में जुलाई 03-07, 2023 के दौरान पूर्वोत्तर राज्यों असम, अरुणाचल प्रदेश, मणिपुर, मिजोरम, मेघालय, नागालैंड, त्रिपुरा और सिक्किम के लिए पूर्वोत्तर राज्यों के लिए लिंग, कार्य एवं सामाजिक संरक्षण विषय पर प्रशिक्षण कार्यक्रम का आयोजन कर रहा है।

यह प्रशिक्षण कार्यक्रम सरकारी अधिकारियों, केंद्रीय ट्रेड यूनियनों के नेताओं और सिविल सोसाइटी के प्रतिनिधियों के लिए तैयार किया गया है। कार्यक्रम का उद्देश्य लिंग, कार्य और सामाजिक सुरक्षा के बीच संबंधों के बारे में समझ विकसित करना और प्रतिभागियों को काम की दुनिया में व्याप्त असमानताओं और श्रम बाजार में महिलाओं के सामने आने वाली चुनौतियों के बारे में बताना है।

यह एक निःशुल्क कार्यक्रम है। संस्थान प्रशिक्षण अवधि के दौरान प्रतिभागियों को आवास एवं भोजन निःशुल्क उपलब्ध करेगा, तथा टिकट की प्रति मिलने पर द्वितीय श्रेणी के स्लीपर रेल किराए की प्रतिपूर्ति भी करेगा। यह सुनिश्चित किया जाए कि केवल उन्हीं प्रतिभागियों को नामांकित करें जिन प्रतिभागियों के पास आधार कार्ड है। प्रतिभागियों के लिए यात्रा किराया की प्रतिपूर्ति केवल एनईएफटी के माध्यम से किया जाएगा। प्रतिभागियों को उनके आधार नंबर एवं बैंक विवरण (बैंक का नाम, बैंक शाखा, बैंक खाता संख्या, आईएफएससी कोड) साथ लाने का निर्देश दिया जाना चाहिए। प्रतिभागियों को आधार नंबर एवं बैंक विवरण टीए फार्म भरने के समय दिया जाना चाहिए।

हम आपसे अपने संगठन से 4 से 5 कर्मियों को नामित करने का अनुरोध करते हैं। यह सुनिश्चित किया जाए कि जो पहले से ही संस्थान के पहले कार्यक्रमों में भाग ले चुके हैं, उन्हें फिर से नामांकित नहीं किया जाता है। हम महिलाओं की भागीदारी की अत्यधिक सराहना करेंगे। आप नामांकित व्यक्तियों द्वारा विधिवत भरे गए नामांकन फॉर्म के साथ प्रतिभागियों के नाम अग्रेषित कर सकते हैं। नामांकन प्राप्त करने की अंतिम तिथि जून 16, 2023 है।

AIM

The programme endeavors to enlighten the participants about the inequalities prevalent in the world of work and the challenges faced by women in the labour market. It would enable the participants in developing an understanding about the linkages between gender, work and social protection. The programme also aims at addressing larger questions of women's empowerment and agency by effective designing of the social protection mechanisms in order to prevent gender based deprivation and ensure social protection through a rights based approach.

OBJECTIVES:

- To develop a conceptual understanding about gender, work and social protection;
- To sensitize the participants about the development issues related to differential access of men and women to employment, education, skill training, health provisions etc and to enhance their capacity to understand and analyze gender dimensions in policy and planning.
- To understand the gendered life cycle risks and nature of vulnerabilities among women across social groups.
- To address the issues of women's unpaid work and other domestic responsibilities in informing policies on social protection;
- To understand the different social protection programme/schemes and good practices that promote employment both at national and international levels;
- To discuss the legislative provisions for women workers on social security.
- To enable the participants to develop an understanding about the role of social protection in ensuring gender equality and agency building of women through a rights-based approach.

COURSE PROFILE

Gender, Work, social protection, code on social security and provisions for women workers, rights based strategies on social protection.

METHODOLOGY

Lectures, class room discussions, experience sharing

PARTICIPATION

Government Officials, Union Leaders from Central Trade Unions and Civil Society Representatives from North Eastern Region

ELIGIBILITY

1. Participants should be above 21 years and below 60 years of age and should be from North Eastern States only.
2. Should be actively engaged at grassroots level activities and have a minimum experience of 2 years.
3. Should have working knowledge of English or Hindi.
4. We will appreciate if some women leaders are also nominated.

Note:

1. Please note that those who have already attended institute's earlier programme are not to be nominated. If so, they shall be immediately sent back and no travel allowance will be reimbursed.
2. Spouse and family members are not allowed to stay in the Institute's hostel.
3. Only members of trade unions should be nominated. Please ensure that spouse or relatives of nominee, who are not member of trade union, should not be nominated.
4. Participants are requested to book their return ticket in advance from their own place.
