Aim	Market-oriented reforms in the health sector have led to low efficiency of resource allocation and utilization, increasing inequality as well as reducing the ability of the poor to access health care services. This situation creates greater health vulnerability for those who are at greater risk of disease but not under the cover of social protection, such as workers in the informal economy.

vii.	Justification/Rationale	<p>Globalisation has led to increasing informalisation of work in the developing countries, whereby workers have less access to social protection. On the one hand flexible, precarious and insecure forms of work with greater health risks have increased. On the other hand, safety and protection systems designed for formal workplaces and workers are inaccessible to informal workers. Moreover, in many developing countries, governments have been compelled to limit welfare programmes including health services through public expenditure. This has increased health insecurities and vulnerability for majority of the workers in the developing countries. It is in this context that the present Course has been designed.</p>
