#### **STAY ARRANGEMENT**

Stay arrangements will be made in the hostel of V. V. Giri National Labour Institute. The boarding and lodging will be provided from the afternoon of July 22, 2018. till the forenoon of July 28, 2018. Accommodation would be on twin-sharing basis. The additional cost of early arrival or extended stay will be borne by the individual participants.

#### PROGRAMME FEE

No fee will be charged. The Institute will provide free lodging and boarding to the participants during training period only.

#### TRAVEL EXPENSES

- 1. No fee is charged from the participants.

The Institute would reimburse travel expenses of the participants for 3 tiers AC Train fare from their place of work to NOIDA on production of ORIGINAL ticket for inward journey and for return journey, a photo copy of 3-tier AC CONFIRMED ticket shall be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconvenience.

- 5. The local conveyance to be reimbursed would be restricted to the actual expenditure incurred or Rs. 750/- whichever is less

- 3. Should have working knowledge of Hindi/ English
