#### AIM

To equip participants with a robust understanding of India's labour law framework, particularly in light of the new Labour Codes and therefore, enabling them to institutionalise legally compliant, socially responsible, and future-ready workplace practices. The programme aims to bridge the gap between legal mandates and startup realities, fostering an ecosystem that values compliance as a strategic enabler for inclusive growth, ethical leadership, and long-term sustainability. The programme will also serve as a platform to discuss existing policies, schemes, as well as the key challenges relevant to Startup ecosystem in the country.

#### THE OBJECTIVES

- 1. To build awareness on the core labour law obligations applicable to startups under India's new Labour Codes.
- 2. To help identifying compliance exemptions, reliefs, and simplified procedures available to DPIIT-recognised startups.
- 3. To provide an overview of the policies and schemes relevant to Startup initiatives.
- 4. To address workplace issues relating to gender, diversity, remote work, gig work, and safety with legal clarity.
- 5. To strengthen organisational leadership for ethical and compliant growth and promote sustainable and equitable work practices within startups.

#### COURSE PROFILE

This three-day training is designed for Startup founders, development experts associated with Startup initiatives, labour officers, incubator representatives as well as management students and research scholars seeking clarity on the regulatory expectations under India's labour law regime. The course delves into essential legal provisions, recent reforms, and future trends relevant to early-stage enterprises. Special emphasis will be placed on gig work, workplace inclusion, dispute resolution, and the legal nuances within the startup ecosystem. Case studies, compliance checklists, and ready-to-use templates will support practical learning.

#### METHODOLOGY

Expert-led lectures, interactive sessions, Case study-based learning and group discussions, experience sharing, and hands-on exposure to compliance platforms and documentation practices.
