The aim of the programme is to develop skills for effective repatriation, rehabilitation of Child Labour and reintegration by ensuring children their rights and protection. The objectives of the programme are to enhance the understanding of the participants on the procedures, and the stakeholders’ role and responsibilities; to develop skills for resource mobilization; and to highlight the importance of convergence of efforts and services for rehabilitation and reintegration; and to equip the participants to contribute towards effective implementation of various projects relating to child labour and child protection. There is no programme fee. The Institute would bear the expenditure on boarding and lodging of the participants for the duration of the training programme. The Institute will also reimburse the to and fro **Second Class Sleeper Train-fare** to the participants on production of tickets. **The reimbursement of travel fare to the nominees would be made through NEFT only.** The nominee(s) may be informed to bring their Aadhar Card and Bank details (name of **Bank**, Bank’s **Branch Name**, **IFSC Code** and **Bank Account Number**) with them as the participants need to fill these details in the TA form at the time of Registration. **The nominations of only those participants will be accepted who have Aadhar Number and Bank Account** and therefore it may kindly be ensured at the time of sending their nominations that each nominee has Aadhar Number.

You are requested to nominate total of 5 representatives one each from Child Line, CWC, Police, DCPU, and Social Welfare Department. Because of limited number of seats, the Institute will be constrained to admit only **Five participants** on first-come-first serve basis and regret acceptance thereafter. The Campus of the V.V. Giri National Labour Institute (**VVGNI**) is situated at Sector-24, near Prakash Hospital and NTPC Ltd. and is at a distance of 20 Kms. from New Delhi Railway Station. NOIDA is situated at Delhi border in close proximity to Mayur Vihar, Delhi.

STAY ARRANGEMENTS

Stay arrangement will be made in the Hostel of the V.V. Giri National Labour Institute at its campus. Boarding and Lodging will be provided by the Institute from the afternoon of Monday, the 18th November, 2019 till the forenoon of Friday, the 22nd November, 2019. Accommodation will be on twin-sharing basis. **For the early arrival and/or extended stay beyond the duration of the Training Programme, charges will have to be borne by the participants.**

TRAVELLING EXPENSES

1. No fee is charged from the participants.
2. The Institute would reimburse travel expenses of the participants for 2nd class sleeper Train/Bus fare from their place of work to NOIDA on production of original ticket for inward journey and for return journey, a photo copy of confirmed tickets should be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconveniences.
3. The local conveyance will be reimbursed restricted to the actual expenditure incurred or Rs. 500/- whichever is less (Rs. 350/- for Delhi & NCR).
4. The Institute would reimburse travel expenses of the **North Eastern participants** for 3 tier AC Train fare from their place of work to NOIDA on production of **ORIGINAL** ticket for inward journey and for return journey, a photo copy of ^{3rd} AC **CONFIRMED** ticket shall be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconvenience. The local conveyance to be reimbursed would be restricted to the actual expenditure incurred or Rs. 750/- whichever is less.
5. It may be ensured that nominee(s) should have Aadhar Card. The nominations of only those participants will be accepted who have Aadhar number. **The reimbursement of travel fare to the nominees would be made through NEFT only.** The Nominees should be instructed to provide Aadhar Number, Bank Account Number, IFSC Code of Bank, Bank Name and Branch of the Bank. The bank details may be indicated by nominee while filling up TA form at the institute.

NOTE:

- **Participants are requested to book their return journey ticket in advance from their own place.**
- **Under no-circumstance other than II class sleeper ordinary fare will be entertained.**

PROGRAMME FEE

There is no Programme fee. The Institute would bear the expenditure on lodging and boarding of the participants during training period.

LAST DATE FOR NOMINATIONS

The last date for receiving the nominations is 4th November, 2019. Because of limited number of seats, we will be constrained to admit participants on first-come-first-serve basis and regret acceptance thereafter.
