

AIM

The programme aims at equipping the participants with the broad scheme and key features of various labour codes.

OBJECTIVES

- Understanding the Background of labour reforms.
- Understanding the key changes; major objectives and features of the various labour codes - The Labour Code on Wages, 2019; Labour Code on Social Security 2020; Labour Code on Industrial Relations 2020; Labour Code on Occupational Safety, Health and Working Conditions 2020.
- Discuss the role of the different organization/bodies to administer the provisions and the penalties.
- Understanding how the reforms will address the issues of the workers and impact the employers and their businesses.

COURSE PROFILE

- Understanding the various labour codes - The Labour Code on Wages, 2019; Labour Code on Social Security 2020; Labour Code on Industrial Relations 2020; Labour Code on Occupational Safety, Health and Working Conditions 2020.
- Understanding the implication of the different Codes on workers and employers.

TRAINING DELIVERY AND METHODOLOGY

This training will be delivered in an online mode. The training will primarily make use of lectures and discussions, followed by questions and answers. Each session will be based on a structured Power Point Presentation. Comprehensive reading materials will also be provided to the participants as a part of the programme.

RESOURCE PERSONS

Faculty members of VVGNI and expert(s) associated with drafting of labour codes and senior labour administrator will be the key resource persons.

PARTICIPATION LEVEL

Labour Officials from Central and State/UTs Labour Departments. Further, as this is an online training, those enrolling in the programme should have access to internet and laptop/desktop with audio-visual facilities.

DATES AND DURATION

This programme is scheduled from January 21-22, 2021. On each day, two online lectures and discussion sessions will be held each for duration of one and half hour (90 minutes), from 10.30 am to 01.30 pm (three hours).
