AIM

The course aims at capacity building of the industry, Public sector undertakings and officials from the Labour Department on issues pertaining to Occupational Safety and Health (OSH). It also aims to enhance the understanding on the legal provisions and policies available at the country for working towards effective implementation of OSH policies at the workplace.

OBJECTIVES

- To provide an overview of the concept of occupational health and safety and discuss legal provisions for ensuring a safe workplace;
- To provide an understanding of International Labour Standards and share good practices on occupational health and safety;
- To discuss in detail the Occupational Health and Safety Working Conditions Code 2020 and the implications of the code on the labour market;
- To discuss the role of various stakeholders for compliance of occupational safety and health standards at the workplace.

COURSE PROFILE

Concept of Occupational Safety and Health, International Labour Standards on OSH, Policy and Legislation on Occupational Health and Safety including the OSH Code 2020, sharing of best practices on Occupational Safety and Health.

TRAINING DELIVERY AND METHODOLOGY

- This training will be delivered in an on-line mode. Participants should have access to good internet connection and computer/laptops with audio-visual facilities
- The training will primarily make use of lectures, case studies and experience sharing. It will also include group discussions and thus be participative in nature.
- The programme will be facilitated by the VVG NLI Faculty, and other lead experts from different Governments and other organizations.
- Each session will be substantiated with structured Power Point presentation wherever required.

Officers from Central and State/UTs Labour/Factories Department and Central Trade Union Leaders.

DATES

- This programme is scheduled during March 30-31, 2021.
- Online lectures and discussions will be held from 10:30 to 13.30 hrs (three hours per training day)
