AIM

Across the globe, gender gaps in the world of work persist both in developed and developing countries. Women continue to experience lower labour participation, higher unemployment and under-employment, vulnerability, informality and precarious employment compared to men. Though gaps are slowly narrowing, gender wage gaps also persist. Such disadvantages faced by women are caused by entrenched patriarchal social norms which continue to shape labour markets, and are very slow to change. Against this backdrop, this training programme addresses the gender dimensions of the global labour market, focusing on unemployment, vulnerable employment and overall sectoral changes during the last two decades. The training also addresses gender dimensions of mega factors, such as demographic transition, globalization, environmental change, and technological change and innovation, which have a profound impact on the future world of work.

OBJECTIVES:

- Addresses the gender dimensions of the labour market, focusing on unemployment, vulnerable employment and inequalities in the world of work;
- Understand changing labour market and employment relations and its impact on decent work and social protection of women workers;
- Address gender dimensions of demographic transition, globalization and technological change and innovation, which have a impact on the future world of work;
- To enable the participants to develop an understanding about the role of different social partners.

COURSE PROFILE

Conceptual understanding of gender dimensions of the labour market, decent work and social protection of women workers, understand the gender dimensions of future of work.

TRAINING DELIVERY AND METHODOLOGY

- This training will be delivered in an online mode. The training will primarily make use of lectures, case studies and experience sharing. It will also include group discussions and thus be participative in nature.
- Each session will be based on a structured Power Point presentation.
- Comprehensive reading materials will also be provided as a part of the programme.
- Participants should have access to internet and computer with audio-visual facilities.
