सहर्ष सूचित किया जाता है कि वी. वी. गिरि राष्ट्रीय श्रम संस्थान जुलाई 18-22, 2022 के दौरान पूर्वोत्तर राज्यों असम, अरुणाचल प्रदेश, मणिपुर, मेघालय, मिजोरम, नागालैंड, त्रिपुरा और सिक्किम के लिए सामाजिक सुरक्षा और आजीविका सुरक्षा पर एक प्रशिक्षण कार्यक्रम का आयोजन करेगा।

यह कार्यक्रम विशेष रूप से सरकारी अधिकारियों, केंद्रीय ट्रेड यूनियनों के ट्रेड यूनियन नेताओं और उत्तर पूर्वी राज्यों के गैर सरकारी संगठनों के लिए तैयार किया गया है। कार्यक्रम का उद्देश्य अनौपचारिक क्षेत्र के श्रमिकों के लिए सामाजिक सुरक्षा और आजीविका सुरक्षा की समझ विकसित करना है। कार्यक्रम का विवरण संलग्न है।



2. Should be working in the area of employment generation, micro enterprise or micro-finance.
3. Should be well-versed in speaking either English or Hindi.
4. Should have a minimum qualification of 12th standard.

The Institute would reimburse travel expenses of the participants for 3 tier AC Train fare from their place of work to NOIDA on production of ORIGINAL ticket for inward journey and for return journey, a photo copy of 3rd AC CONFIRMED ticket shall be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconvenience.
3. It may be ensured that nominee(s) should have Aadhar Card and bank account. The nominations of only those participants will be accepted who have Aadhar number and bank account. The reimbursement of travel fare to the nominees would be made through NEFT only. The nominee(s) may be informed to bring their Aadhar Card and bank details (name of bank, name of bank branch, IFSC code and bank account no.) with them. The bank details may be indicated by nominee while filling up TA form at the institute. All the nominees may be informed accordingly.

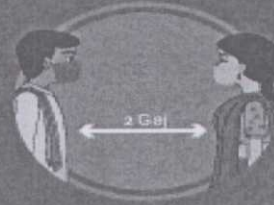
