- Understand livelihood risk and vulnerability of the rural poor.
- Understand the different social protection programmes that transfers assets and skills people for self-employment and public works programmes that enable people to cope with poverty.
- Explore the alternative coping strategies/good practices for poverty reduction.

METHODOLOGY

PARTICIPATION LEVEL

ELIGIBILITY

- 1. Participants should be above 22 years and below 50 years of age;
- 2. Should be personally engaged at grass root level activities for at least past two years;
- 3. Should be fluent in either Hindi or English.

NOTE:

- Please note that those who have attended Institute's programme earlier are not to be nominated. If so, they shall be immediately sent back and no travel allowance will be reimbursed.
- 2. Spouse and family members are not allowed to stay in the Institute's hostel.

DATES

July 25-29, 2022

The training programme will commence at 10.00 a.m. on July 25, 2022 and will conclude in the afternoon on July 29, 2022. The timings would be from 10:00 am to 05:00 pm.

VENUE

V.V.Giri National Labour Institute Sector –24, NOIDA –201301,

The campus of Institute is situated near Prakash Hospital and NTPC Office. The distance of the campus from New Delhi Railway Station is 20 Kms. Noida City Centre Metro Station is about 1.5 kms from VVGNLI, Noida. The nominee(s) may be informed accordingly.

STAY ARRANGEMENT

Stay arrangement will be made in the hostel of V.V. Giri National Labour Institute. The boarding and lodging will be provided by the Institute from the afternoon July 24, 2022 till the forenoon of July 30, 2022. The accommodation would be on twin sharing basis. For extended stay or early arrival, lodging & boarding charges would be borne by the participants.

TRAVELLING EXPENSES

- 1. No fee is charged from the participants.
- 2. The Institute would reimburse travel expenses of the participants for 3 tiers AC Train fare from their place of work to NOIDA on production of ORIGINAL ticket for inward journey and for return journey, a photo copy of 3rd AC CONFIRMED ticket shall be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconvenience.
- 3. It may be ensured that nominee(s) should have Aadhar Card and bank account. The nominations of only those participants will be accepted who have Aadhar number and bank account. The reimbursement of travel fare to the nominees would be made through NEFT only. The nominee(s) may be informed to bring their Aadhar Card and bank details (name of bank, name of bank branch, IFSC code and bank account no.) with them. The bank details may be indicated by nominee while filling up TA form at the institute.
- 4. The participants form Assam and Meghalay can submit a copy of Voter ID/ Driving License in place of Aadhar card, while filling up TA form at the institute. All the nominees may be informed accordingly.
- 5. The local conveyance to be reimbursed would be restricted to the actual expenditure incurred or Rs. 750/- whichever is less


