INTRODUCTION

There are now more than 45 lakh beedi workers engaged in beedi industry in the country. Though there are unions of the workers but most of the unions have been found requiring training in order to make their activity more effective for protecting interest of the workers.

The Government of India under the Ministry of Labour and Employment operates welfare fund for beedi workers. It was found that due to lack of information on the part of unions as well as workers the utilization of fund has been quite disappointing. Keeping this in view the present programme is proposed to be conducted by the Institute to help the workers'/ unions acquire leadership skills so that they can be more effective in organising workers and providing various other benefits.
